- Provide a detailed description of any promotional, marketing, or other benefits. Include any incentives or rebate programs offered or any sponsorship opportunities available as part of your letter.
- Describe the customer service plan and delivery schedule for individual online orders.

- Include brands and pricing for the following items in youth and adult sizes:
 - o Soft-style t-shirt
 - o Long-sleeve t-shirt
 - Hoodie
- Potential for larger orders from College personnel
- Turnaround time from order to shipment
- Ablity to ship directly to the customer
- Ability to expand apparel offerings after launch
- Ability to have the online store available by June 1, 2024.
