These services are being added to this bid as Alternate One.

Objective

Rock Valley College is seeking services of brush control and mowing on land adjacent to the Advanced Technology Center in Belvidere, IL. The property is non-landscaped and was used as cornfields prior to RVC's acquisition of the land. Services are needed to bring grass, weeds, and underbrush to well within the requirements of the City of Belvidere. Due to the nature of the current conditions, Brush Hog equipment or similar is expected to be necessary to provide these services.

Vendors are invited to submit a response for the base bid and Alternate One. Vendors will not be disqualified if they choose not to bid on Alternate One. The award of base bid and Alternate One may be split between two vendors depending on the best interest of the College.

Scope of Alternate One

- ATC – Advanced Technology Center – 1400 Big Thunder Mall
 - Mowing and brush control of non-landscaped area - 2x/mo
